What % of the piping used is PVC flex piping? **Minimal because of flow resistance.**

Where is it used? **Only off of Skimmers, Bottom Drains, and non "straight runs".**

If you use Brick Coping, do you use wire cut brick? **Seldom**

How is it prepped? **For long life the bottom must be sandblasted for bonding.**

What brand, size, and type (ball, sealed ball, diverter) valves do you use? **Only high-end Pentair 2" diverter Valves.**

Do any of your construction phases use Acrylic or Polymer additives? **All bondcoats and tile beds - that is why we have the industrys longest warranties.**

Support

After the project is complete, what services and support do you offer to the pool owner? **Service and retail store on Rte 309 with full valet services, free expert water testing and full customer training and support - and we are open 7 days a week!**
